In a continuing collaborative effort with the Ohio State Medical Association, Ohio Hospital Association and the Ohio Osteopathic Association, OHPCO distributes the Advance Directive Packet: *"Choices, Living Well at the End of Life."* We also thank the Ohio State Bar Association for their help in updating language used in the Living Will, Donor Registry Enrollment Form and the Health Care Power of Attorney document which conforms to the requirements of Ohio's law, as amended effective December 15, 2004.

The Ohio End of Life Collaborative has also developed a document to guide conversations and help individuals communicate their wishes called *Conversations That Light the Way*. Both the *"Choices..."* Advance Directive Packet and the *"Conversations"* are on our web site and can be downloaded and printed at no cost using Adobe Acrobat Reader software. Both the Advance Directive Packet and Conversations brochures can be ordered through our office and are great pieces to help educate individuals in regard to their choices regarding advance care planning and decision making.
